Minutes of the May 20,2021 meeting at the Transportation Center

President, Amy Richards, called the meeting to order at 7:00 pm

Approve Minutes: President Amy Richards asked for a motion to approve the April 15, 2021 minutes. A motion was made by Matt Hignett and seconded by Dick Heidecker; motion carried.

Treasures Report: At the April meeting we had a checking balance of \$18,053.17. We had \$20 come in for an associate membership. Our expenses were \$130 for New Russia (hall cleaning). This leaves us with a checking balance of \$17,943.17. The Huntington CD balance is \$5,703.60. The Chemical Bank CD is \$5,222.01. Our assets total \$28,868.78.

President Amy Richards asked for a motion to approve the treasures report. A motion was made by Amy Richards and seconded by Carl Wesemeyer; motion carried.

The group discussed ways to invest some of our assets to earn more interest. Neil Lynch suggested using a discount broker. The discussion will continue at the June Meeting.

Program: Elizabeth Doyle, Crime Lab Director presented an overview of the services provide by the Crime Lab to law enforcement, the court system and residents. The goal is for the Crime Lab to be certified, to be certified the lab will need a permanent home and funds to upgrade equipment and technology. A decision regarding a levy in November to support the Crime Lab is forth coming.

State Senator Nathan Manning, State House Representatives Gayle Manning and Dick Stein conducted a round table discussion. Topics included committees each representative is a member of, the state budget bill, election reform bills, how electric vehicles will impact the gasoline tax monies going forward, state's sports gaming bill, reduce the number of state mandated test in K-12, the insulin availability bill, wind turbine and solar farms regulations and the state rules regarding annexation that need to be revisited.

Orrin Leimbach talked to our state representatives about the Step-Up Base, that heirs have to pay capital gains tax after inheriting their parent's farm or business. This sometimes forces the heirs to sell off a portion of the business or farm to pay the tax. This is a federal government issue. Orrin wanted to make everyone a where of the issue and to reach out to our federal representatives.
